OVERVIEW

Public transportation in the City of Harrisonburg is provided by the HDPT, a department within the city government. HDPT operates fixed-route bus service, Americans with Disabilities Act (ADA) complementary paratransit service, scheduled shuttles to Bridgewater and Dayton, and school bus service. The transit system operates six year-round routes geared towards city residents and numerous seasonal routes during the school year, geared towards the needs of JMU students.

HDPT operates six year-round, fixed-route bus services generally within the city limits of Harrisonburg, and a limited-service shuttle that provides a connection between the neighboring communities of Dayton and Bridgewater on Tuesdays and Thursdays, respectively. Additionally, HDPT offers 30 fixed-route buses oriented to the needs of JMU students during the traditional academic year. The central transfer location for JMU-oriented transit services is the Godwin Transit Center, located on the JMU campus. Americans with Disabilities Act (ADA) complementary paratransit service is also provided.
