





Average Age of Housing Stock in CSPDC Region (2019)




- Median age of homes in the region: 1970-1979






- On par with the state (66% owner, 34% renter)




Median Household Income in the CSPDC Region







- Our region's housing landscape is characterized by a significant amount of variation. Addressing affordability will require tailored, location-specific approaches.




